Criminal Trial Workshop

Many Newly Qualified Solicitors and Trainees will have had limited opportunity to enhance their court skills since leaving University and therefore may lack some confidence, experience and understanding of common legal concepts when they finally make their way into court.

This workshop has been designed to bridge the gap and provide a platform to practice your skills in a 'Mock Trial' environment which will centre on an examination of the case of PF v Charles Mackintosh – a case adapted from an actual prosecution, with key input from the case's PF, Claire Nicholls.

The Workshop will be a mixture of Lecture, role play at trial and group work around this case which covers many of the key concepts which come into play for daily practitioners.

- Criminal Procedure (Scotland) Act 1995 s159 (amending Complaint)
- → Special defence of Alibi
- → Vulnerable /child witnesses –s 271 (s 271A)
- → Leading of witnesses and cross-examination
- → Examination of Criminal Justice and Licensing (Scotland) Act 2010 s38(1)
- → Use of emulator sheets and ID parade
- → Examining dock ID and alternatives
- → Introducing use of prior inconsistent statements under s263(4) and Jamieson No 2
- Applying Moorov doctrine
- → No case to answer submission under CPSA 1995 s160(1)
- → Notification requirement under Sexual Offences (Scotland) Act 2009
- → Notification requirement under Sexual Offences act 2003 Schedule 2 para 60 'significant sexual aspect'
- → Examination of relevant cases including PF v Hay 2012.
- → Closing Crown and defence submissions
