Part 2- Current issues in Clinical Negligence litigation in Scotland

The success of a clinical negligence case depends to a large degree on the expert evidence obtained from healthcare professionals, and this requires careful instruction of the correct expert. We will consider the duties and role of an expert witness, what the expert needs in their instructions, what documents to submit for consideration, how the report should be set out, and the use of documentation to support the expert opinion.
