It is now over four years since the Taylor Report proposed quite sweeping changes to the system of funding and expenses for civil litigation. We now have the Civil Litigation (Expenses and Group Proceedings) Bill about to come into force in the near future and various proposals which ultimately will require changes to the Sheriff Court and Court of Session Rules to implement. In certain areas such as summary assessment of expenses the Courts have already taken proactive steps. What changes are likely to come in and when?
